Dear Users,

The purpose of this manual is to ensure the safe use of bicycle repair and charging stations, as product safety is our highest priority. We comply with the current regulations of the European Union regarding the safety of technical products. Please familiarize yourself with this manual to ensure that using IBOMBO[®] repair and charging stations is both safe and convenient.

Purpose of the document

This instruction has been prepared in accordance with Regulation (EU) 2023/988 of the European Parliament and of the Council of 10 May 2023 on general product safety, amending Regulation (EU) No 1025/2012 of the European Parliament and of the Council and Directive (EU) 2020/1828 of the European Parliament and of the Council, and repealing Directive 2001/95/EC of the European Parliament and of the Council Directive 87/357/EEC. The document contains general rules for the use of IBOMBO[®] products and guidelines for emergency procedures.

Scope and application

This instruction covers all bicycle repair and charging stations manufactured by IBOMBO[®] and sold within the European Union. The products are intended for public use and urban spaces. A list of IBOMBO[®] products, along with product data sheets containing detailed descriptions, is available at http://www.ibombo.com.

General safety guidelines for use

- 1. Verify Product Labels Before using the repair or electric bike charging station, ensure that all labels are legible and complete (e.g., QR codes with repair instructions, warning labels).
- Read the Installation Manual Before starting the installation of the bike repair/charging station, carefully read the installation manual. For a copy of the installation instructions, please contact IBOMBO[®] Customer Service at contact@ibombo.com or by phone at +48 730 070 730.

- 3. Follow the User Manual Review the repair instructions for common bike issues before using the IBOMBO[®] repair station for the first time. Repair guides are available as video tutorials at www.ibombo.com/repair. The website address and QR code are displayed on every bike repair station.
- 4. **Appropriate User Age** IBOMBO[®] bike repair and charging stations should be used by adults or children under 12 under adult supervision. Ensure that users have the necessary skills and knowledge to operate the station properly. To avoid the risk of injury or equipment damage, children and dependent individuals should only use the station under responsible adult supervision.
- 5. **Intended Use Only** Use the station exclusively for bike repairs and charging in accordance with its intended purpose.
- 6. **Technical Condition Check** Regularly inspect the station's technical condition, particularly tools, the pump, adapters, charging modules, and structural or mounting connections.
- 7. **Report Defects** Report any malfunctions to the administrator, property owner, or manufacturer for prompt resolution. If defects pose a danger to users, secure the station to prevent use by third parties.
- 8. **Maintain Cleanliness** After completing repairs or charging, leave the station clean by returning tools, the pump adapter, and cables with plugs (if applicable) to their designated places.

Precautions

- 1. **Tools or devices under voltage** Use tools according to the instructions. In case of any damage, stop using the station immediately.
- 2. **Charging electric bicycles** Only use designated sockets and cables for charging. Do not leave an electric bicycle unattended while charging. If you notice any damage to the electrical socket, refrain from using the device and notify the property owner or administrator immediately.
- 3. Exercise caution When using the station, take extra care to avoid injuries:
 - Cuts or abrasions from sharp tool edges.
 - Pinching of fingers when using manual tools, hand pumps, or adapters.
 - Injuries caused by a falling bicycle during repairs if the bicycle is not securely mounted on the stand.
 - Head injuries, such as bruises, abrasions, or more serious trauma from hitting the bicycle mounting stand. Always be aware of the stand's position and maintain a safe distance during repairs.
 - Cuts from small components or debris during repairs (e.g., chain tensioning or screw removal).
 - Electric shocks from damaged cables or sockets.
- 4. **Prohibition of modifications** Modifying or altering the repair/charging station or tools is strictly prohibited. Only components from the manufacturer's wide range of spare parts or those recommended by the manufacturer may be used.

Maintenance of tools and pump

To ensure the trouble-free operation of the repair and charging stations, regular maintenance of tools and the pump is essential. We recommend conducting technical inspections as outlined in the Warranty Card provided with the device. The toolset should be maintained regularly – at least once a month – using products recommended by the manufacturer, such as Molydal TOP5 or BERNER cleaning and maintenance products for A2/4 steel. The pump piston should also be maintained regularly – at least once a month – using Motorex Fett 2000, and the condition of seals should be checked. Powder-coated surfaces should be cleaned periodically – at

least once a month – and waxed after cleaning. The manufacturer recommends using synthetic wax such as Meguiar's Ultimate Liquid Wax 10.

- **Directive 2011/65/EU** of June 8, 2011, on the restriction of the use of certain hazardous substances in electrical and electronic equipment.
- **Directive 2014/53/EU** of February 16, 2014, on the harmonization of the laws of the Member States relating to the making available on the market of radio equipment and repealing Directive 1999/5/EC.
